
- (1) Mr. Md. Arifuzzaman, Divisional Railway Manager, Bangladesh Railway, Dhaka.

2. The sanction is subject to the following terms and conditions:

- a. The tour will be treated as on duty ;
- b. All expenses in this connection shall be borne by Mir Akhter-Ranken JV;
- c. The officials will draw their pay and allowances in local currency; no part of it shall be drawn in foreign currency;
- d. They will not be allowed to stay abroad more than the approved period.
- e. They will have to submit a report to the Ministry of Railways after completion of the tour.


