Government Order

The undersigned is directed to convey the sanction of the Government of the People's Republic of Bangladesh in favour of Mr. Md. - He has to submit a report on the visit within a week after his return from India.
- He will leave Dhaka for New Delhi, India on 6 September, 2017 or nearer suitable date and return to Dhaka on 9 September, 2017 or nearer suitable date.
