They are entitled to draw Pocket Allowance equivalent to 30% of the Comprehensive Allowance as stated in the office Memorandum No.AMa/AaBi/Ex.Control-2/2(19)/2000-04/Part-1/221(1000) of the Finance Division, Dated:9 October, 2012(Paragraph 7 Ka and 11) with its latest amendment(Circular of Finance Division, No. 87.152.099.00.001.2004-35 dated 24/8/2015) and Office Memorandum no. AMa/AsBi/Ex.Control-2/2(19)/2000-04/Part-1/67 of the Finance Division, Dated: 10 March, 2013 for the travel period.
- e. They will draw their Pocket Allowance from the budget allocation of TA Code of their respective offices.
